Lincoln County Cities

Alamo

Alamo is the principal town of the Pahrangat Valley. Celebrating its 100th anniversary in July, 2001. The town was laid out in 1901 by Fred Allen, Mike Botts, Bert Riggs, and William Stewart, and was settled largely by individuals from Fredonia, Arizona.

The Post Office was established on May 12, 1905. The name of the town was derived from the Spanish word for "poplar" and denotes the presence of poplar or cottonwood trees in the area.

The main industry is farming and cattle ranching. The unincorporated town is the southernmost community in Lincoln County, situated on Highway 93, about 90 miles north of Las Vegas. The community is at 3449 feet in elevation, and encompasses an area of about 720 acres in size and a population of about 900. The July average high temperature is 96 degrees Fahrenheit and 6.5 inches annual rainfall.

Alamo features the Pahrangat National Wildlife Refuge. An important stop on the Great Pacific Migratory Route, dozens of bird species can be found here. With the abundant water source, established in 1964, The PNW is over 5000 acres of wetlands and grass lands managed for the thousands of migratory birds and waterfowl that fly through the area. This refuge is one of over 500 in the National Wildlife Refuge System. Fishing is great too! For more information about the NWR System please feel free to look at <http://www.fws.gov>.

Alamo is one of the closest inhabited places to the government installation known as area 51. Today Alamo attracts visitors to it's Hot Springs, Lakes, Wildlife Preserves, and people interested in Indian Artifact.

Alamo is a full service community offering food, lodging, shopping, automotive, emergency services and landing strip for small private planes.

Caliente

Caliente is the only incorporated community in Lincoln County and is located in southeastern Nevada, about 155 miles north of Las Vegas on about 1022 acres at 4,300 feet above sea level. A state park, Kershaw Ryan is just South of Caliente.

The meadows around the junction of Meadow Valley and Clover Washes were settled in the early 1860's. Charles and William Culverwell bought properties and provided hay for the mining camps in Pioche and Delamar. This land was 25 miles south of Pioche, and 14 miles south of Panaca.

A fracas between the Harriman's and the Clark's rail construction crews was brought to an end by Culverwell and his shotgun in 1901. This led to the establishment of Caliente as a division point for the railroad.

This same year a Post Office opened and the town was named Caliente (Spanish for "hot"), after the hot springs found in a cave at the base of surrounding mountains. For more than 40 years, Caliente was one of the major division points on the railroad. When steam engines were replaced by Diesel Locomotives in the 1940's, the division point moved to LasVegas.

Services available include gas, grocery, lodging, food, entertainment, RV parking, automotive repair, emergency services, hospital and clinic.

Hiko

Historic County seat and Mining Town. The town of Hiko, first established in the late 1860's, is located in the north end of the Pahrangat Valley. Early in 1865, Indians who knew of silver in the Pahrangat Valley areas revealed its location to settlers in March of that year, and by October, a camp was established at Hiko. The name is said to have been a Shoshone Indian word meaning "white man" or "white man's town."

A "rush" occurred in early 1866 and produced a population of a few hundred residents. During this year, William Raymond purchased many "squatter's claims" and laid out a town site after obtaining the necessary capital in the East. The new facility, including a five-stamp mill, started up in November, 1866. However, because of the absence of skilled workers, this effort soon failed and by 1871, the mill and county seat had moved to Pioche. The only evidence of this early mining activity today is the stone ruins and the graveyard.

Hiko is now home to several ranches and many types of recreations.

Panaca

Panaca is the second oldest community in Nevada. Having been settled by Mormon Pioneers in 1864. Panaca is a small farming community situated approximately halfway between Pioche and Caliente, one mile east of Highway 93 on S.R. 319.

Panaca's primary industry is farming, but also neighbors one of Lincoln County's five state parks, Cathedral Gorge, which hosts year round camping and exploration.

The Lincoln County Airport is situated about two miles west of Panaca and can accommodate small aircraft. The airport is presently being considered for updating and renovation.

The town is steeped in history and many of the original homes and business buildings still stand today.

Services available include groceries, gas and RV parking.

Pioche

Pioche is the northern most community in Lincoln County, located about 185 miles north of Las Vegas on U.S. 93.

Guns were the only law, and Pioche made Bodie, Tombstone, and other better known towns pale in comparison. It is said that there were 75 people killed before one person died of natural causes. In 1864, an LDS missionary, William Hamblin, was led to silver deposits in the vicinity of Pioche by a Paiute Indian. In 1869 Francois L.A. Pioche purchased property and formed the Meadow Valley Mining Company. The mining camp was called "Pioche's City" and later became known as Pioche.

The town rapidly became known as the largest mining town in southeastern Nevada in the early 1870's. The town quickly became known for its "toughest town" reputation, due mostly to gunman, often when that didn't work they would take it to court where bribery often determined the final outcome. During which time the Sheriff's office was reputed to be worth \$40,000 a year in bribes alone.

Not even the building of the county courthouse was exempt from corruption. Pioche was designated the county seat in 1871 and the courthouse plans were initiated. At the outset the contract was let for \$16,400. Instead, construction proceeded on a piecework arrangement with repairs and alterations occurring the very first year. In the end, construction costs were \$75,000. To finance the courthouse, the Board of Commissioners issued certificates of indebtedness at a high rate of interest. More script was issued. Default followed and the final payment, made in 1936, fixed the final cost of the Lincoln County Courthouse at \$1,000,000.

The fortunes of Pioche diminished in the 1880's, due to the shutdown of the principle mines in 1876. Today, Pioche is a quiet, picturesque town filled with reminders of its turbulent past. Pioche is the Lincoln County Seat, with the "new" courthouse a prominent fixture of the town. The annual Labor Day celebration is the biggest event of the year.

RV parking, automotive repair, emergency services.

Rachel

Rachel is the youngest town in Nevada, the town is twenty-five years old and is situated in Sand Spring Valley in western Lincoln County.

Rachel, named after Rachel Jones, the first child born in the community, founded by D.C. Day in 1978, is on Hwy. 375, which was renamed “The Extraterrestrial Highway” by the Nevada Legislature. The town has been featured in magazines, books, television shows, and many major news papers as the center for UFO activity that has drawn Sci-Fi fans and visitors from all over the world.

The Nevada Test Site is situated in western Lincoln County, close to Rachel. However, for obvious reasons, there are no guided tours. Warning signs are posted for visitors who get too inquisitive.

In and around this little town, alfalfa is grown and cattle are raised. Western history buffs may want to check out the mountains surrounding Rachel. Rachel is also surrounded by mines, mining relics, and Indian caves. Paiute Indians left behind artifacts such as arrowheads, petroglyphs and other signs of encampments. Old ghosts are said to frolic in nearby towns and at the old stage coach depot. The area abounds with interesting walking and driving sites to visit.

Located on S.R. 375, 40 miles west of the junction of S.R. 318 and U.S. 93.

Rachel is a full service community offering food, gas, entertainment, and emergency Services.

Ursine

Ursine is a small historic community, 16 miles northeast of Pioche, settled by a small colony of Mormons in 1863 in Eagle Valley. This one street community at the head of Eagle Valley Canyon was developed as a farming and cattle raising area. A Recreation Hall which also served as a school and church building, as well as the many homes have been occupied since the late 1800's. The Ursine post office was in operation from about 1895 to about 1980.

This small community boasts the Spring Valley State Park, which includes Eagle Valley Lake with fishing, and camping available. Located north on S.R. 322 about 13 miles from Echo Canyon turnoff, or it is about 17 miles northeast of Pioche via the Eagle Valley road to the town of Ursine, also commonly known as Eagle Valley.

Ursine has small convenience store, entertainment, and RV parking.

Lincoln County 1999-2000

Lincoln County is one of the 17 counties in Nevada. It is not part of a Metropolitan Area. Year 2000 population of 4,178 ranks 14th in the State.

Per Capita Personal Income

Year 2000, Lincoln County had a per capita personal income (PCPI) of \$22,805. This PCPI ranked 13th in the State, and was 77 Percent of the State average, \$29,506, and 77 percent of the national average, \$29,469. The 2000 PCPI reflected an increase of 3.1 percent from 1999. The 1999-2000 State change was 2.5 percent and the national change was 5.8 percent.

Total Personal Income

In 2000, Lincoln County had a personal income (TPI) of \$95,280*. This TPI ranked 14th in the State and accounted for 0.2 percent of the State total. The 2000 TPI reflected an increase of 4.6 percent from 1999. The 1999-2000 State change was 7.0 percent and the national change was 7.0 percent.

Components of Total Personal Income

Total personal income (TPI) includes the earnings (wages and salaries, other labor income, proprietors' income); dividends, interest, and rent; and transfer payments received by the residents of Lincoln County. In 2000, earnings were 63.0 percent of TPI; dividends, interest, and rent were 19.2 percent, and transfer payments were 17.8 percent. From 1999-2000, earnings increased 4.4 percent; dividends, interest, and rent increased 4.8 percent; and transfer payments increased 5.2 percent.

Earnings by Industry

Earnings by persons employed in Lincoln County increased from \$59,839* in 1999 to \$61,159 in 2000, an increase of 2.2 percent. The largest industries in 2000 were services; state and local government, 33.8 percent; and transportation and public utilities, 5.6 percent. Of the industries that accounted for at least 5 percent of earnings in 2000, the slowest growing from 1999 to 2000 was state and local government, which decreased 1.6 percent; the fastest was transportation and public utilities, which increased 10.2 percent.
